## The Problem

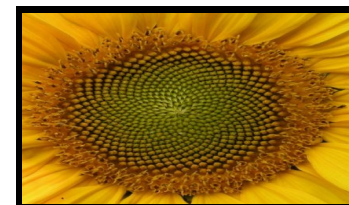
